- 2. Student Survey Results Nina Chanana:
 - a. 2,781 surveys completed (7th through 12th grades), 14% identify LGBTQ+, 5% identify their gender as "other"
 - School climate (teachers/students care) is steady; students reporting adults value youth increased, although lower for LGBTQ+ and "other" gender, and decreases as grade level goes up
 - c. Many teens know where to go for help with mental health/substance use, but rates are declining
 - d. 32% of middle school and 43% high school report persistent sad/hopeless feelings, up since 2019; rates are higher for females, LGBTQ+ and "other" gender
 - e. Almost half of high school students report extreme stress from academics
 - f. Reported parental vigilance is high and increasing, and reported peer approval of substance use is declining
 - g. Vaping peaked in 2017 and is declining; perception of harm and parental disapproval is increasing
 - h. Past 30-day substance use and binge drinking are down substantially since 2017; however, rates increase with grade level which suggests we need to reach older students and their adults with programs/messaging rates are also higher for LGBTQ+, "other" gender and whites
 - i. Rates are lower for students who report high parental vigilance and modeling, that adults value youth and that teachers care about them; rates are higher for students who report parent approval of use and among youth who report persistent sad/hopeless feelings
 - i. Youth who report their parents don't think it's a big deal to use are twice as likely to drink and almost 8 times more likely to use marijuana
 - j. Perceived risk of use is up for all substances
 - k. Increase in students reporting accessing alcohol from homes and parents and drinking at home with a parent's knowledge
 - I. Seniors are more likely to drive under the influence or ride as a passenger with someone under the influence
 - m. 1 in 5 students report gambling in the past year
