- 1. Introductions & Partner Updates:
 - a. Coalition members are encouraged to support TPAUD's request for funding from the American Rescue Plan Act (ARPA) funds, to sustain TPAUD for two years after its DFC grant expires in 2024. Coalition Members can voice their support in-person at the Trumbull Town Council and Board of Finance Public Hearing on 11/17/22 in Council Chambers at Town Hall at 7:00 p.m. In addition, coalition members are encouraged to email their support for TPAUD to Town Council and Board of Finance members individually.
- 2. Current Prevention Activities
 - a. 9th Grade Forum Follow-up and Advisory Lesson:
 - i. Forum: Very well received, parents were engaged. Liked having both videos and live presentations. Next year there should be less focus on drunk driving.
 - ii. Advisory Lesson: TPAUD provided an activity for 9th Grade Advisory as a follow-up to the Forum. The lesson focused on finding your "why" (to choose not to use), refusal skills and exit strategies.
 - b. Marijuana Social Media Education Campaign: TPAUD and Daydream Communications designed an educational campaign aimed at caregivers and youth. Social media posts with messaging on potency, driving under the influence of marijuana, educational outcomes, and youth mental health will run on Facebook, Instagram, Snapchat and YouTube through the beginning of January. Some posts on marijuana potency have been blocked by Facebook; the appeal process is difficult.
 - c. Retailer Environmental Scan: Zach Rudich is working with Nina Chanana on an Environmental Scan of businesses in Trumbull that sell vapes, CBD and THC. The scan will provide information on what products are available to Trumbull youth and how they are sold, and will help determine how well local retailers are adhering to local/state laws and regulations.
